### Timo Ingalsuo attacked the accused

Timo Ingalsuo, who died in the case, had attacked the accused from behind.

### Korvausvaatimukset

This could very well be self-defense, where the attacker was killed, but these cases go into the category of state interest, which means court decisions to get future problem citizens caught in the clutches of the authorities, i.e. human rats, bought from the country's courts at a cheap price from the state's point of view, but which are extremely expensive for the relatives of bystander victims in terms of pain .

This case is really strange in that the accused had been admitted to involuntary treatment against his will and he had said that he was hearing voices inside his head. For these clients of psychiatry who have been forcibly taken under their purview, all of which are medical malpractice, almost every case escalates into the death of a bystander as in this case, even though the victim had a hand in his own death by attacking the accused from behind.

### **There is no motive**

The courts have focused on finding a motive for this fatal accident, which unfortunately seems to me almost like an accident or an accident that started when the accused was attacked from behind by an unknown person. This case is very close to a normal bar fight, which escalates to the level of causing the death of the other under the influence of alcohol and passion.

These cases where the authorities are driving our country's problem citizens like Ylivieska's church arsonist Jouni Kauppila from the free side of society to the human rat farms managed by the University of Turku, is a very common practice in connection with them, namely the desire not to see or acknowledge the motives, which was however clearly visible in the case of Jouni Kauppila even from the news and who burned the Ylivieska church in revenge for all the unjust actions that the authorities directed at him in the form of unjust sentences and by believing Kauppila in medically non-existent diseases in the name of which he was fed harsh chemical compounds only for the purpose of drugging.

A message should be sent to the prosecutor's office and the Finnish stupid group that there is no motive for all cases that lead to death if they are an accident, an accident or the death of another person caused by an argument that started with wrestling in the morning hours of Christmas Eve.

At this point in the investigation, I see the situation only as a profit motive for the Finnish authorities with this case, with which it creates credibility and grows a channel in the sentencing process that works in a completely dictatorial manner and which it uses with other problem citizens who are taken to the human rat farms managed by the University of Turku and are not allowed back out into the free side of society, even as entrepreneurs and is the main reason why I don't put the name and picture of this entrepreneur in this article...but this may change in the future when I study the activities of organizations in our country, which would seem to be very popular with the decision-makers of our country when they guide our society in the name of democracy, of course with the help of the activities of these organizations.

### **Judgment for negligence of rescue operation**

**syytetyn veli** on edellä todetulla tavalla seurannut sivusta, kun **syytetty** on pahoinpidellyt Timo Ingalsuota, ja hän on molempien kertomusten mukaan pyytänyt tätä lopettamaan pahoinpitelyn. **syytetyn veli** on siten voinut havaita, kuinka voimakasta Timo Ingalsuohon kohdistettu väkivalta on ollut. Valokuvailiitteen kuvista käy ilmi, että Timo Ingalsuon vammat ovat olleet selvästi havaittavissa. Pahoinpitelyn laadusta ja sen ajallisesta kestosta sekä **syytetyn veli** päihtymystilasta esitetyn selvityksen perusteella poissuljettua on, että **syytetyn veli** ei olisi kyennyt tekemään tapahtumista totuudenmukaisia havaintoja.

Edellä törkeän kuolemantuottamuksen kohdalla on todettu, että Timo Ingalsuo on jäänyt 1,5-3,8 asteen pakkassäässä loukkaantuneena ja päihtyneenä istumaan ojan reunalle rata-alueen lähistölle, kiskojen ja aidan väliselle alueelle, jossa ei normaalisti kukaan liiku ja joka on sijainniltaan syrjässä.

Tällä lisäyksellä hovioikeus hyväksyy käräjäoikeuden tuomion perustelut ja lopputuloksen kohdan 2 pelastustoimen laiminlyönnin osalta.

The accused was convicted of negligence in rescue operations even though the victim was wearing the correct clothing and he started the situation by attacking the accused from behind.

From this situation, I am left with an image of the courts as a dumping ground that looks down on the illegalities of the Finnish authorities and where only wrongful convictions are handed out to the citizens who seek weight without ignoring the means to increase the sentence and by dumping this negligence of the rescue action on the accused when the victim had himself started the fight by attacking the accused from behind.

These wrongful convictions will have a great significance when innocent Finnish citizens start to be sentenced in our country's courts for actions they have not committed, or similarly at a point where Europe's new plague, the black death of problem citizens, a double agent who defected to the Kremlin's desks, and real-life "wannabe" James Bond images on Tinder the henchmen of Sauli Niinistö,



who stole the narcissistic personality disorder Hannu Lauerma's diaries from the nation, are murdering Finnish citizens in medical clinics in the name of damages and accidents, for which these henchmen of the new European plague sneak out of the back doors of the courts like chickens from a cage.
