This case arouses my interest because the case is somewhat similar to the killing of a spur, where the perpetrator had been taken twice to compulsory treatment against his will, where the psychiatrist had recorded in his medical records that he hears "voices", which in these cases are connected to delusions that control these people. In addition, there was speculation in the court decision that the killer was under the control of these "voices" during the murder. In the case of Kannus's murder, no picture or personal information has been published for the news, just like there is no author of the Kokkola school murder project and the court decision I received from the Vaasa Court of Appeal, I was able to find out where this Kannus' killer is today because I would have liked to interview him about the cases. It became clear to me that the killer who was sent to compulsory treatment by the decision of THL on 04/2020 has been on the free side of our society as a gym entrepreneur since 06/2022 and this person does not hear any of the "voices" that psychiatry had mentioned about him. This killer is a really matter-of-fact looking and otherwise smart guy, which makes me wonder why psychiatry has recorded such false information about him and that he has been taken to psychiatric treatment with the help of compulsory medical treatment laws, which would appear to many to be medical abuse and medicinal torture in the name of imaginary diseases.
