VISIT TO THE NURMJÄRVI ER 12.04.2019 at 17:00 (HENRIIKKA RIEPPONEN)

After leaving Focusplan in 06/2018 (article to come), I have been troubled by constant muscle twitches in my thighs and eyes, and constant numbness in my legs and hands. Twice the numbness has been so intense that I've been a little panicked that it will lead to some sort of permanent condition.

Nurse Päivi Kokki who does not use disinfection when taking samples

When I went to the emergency room in Nurmijärvi, I was taken CRP during the recording phase because the nurse wanted this. However, he did not clean my finger with a disinfectant and before taking CRP I said to the nurse that "shouldn't the finger be disinfected?" The nurse replied "no need". Well, at this point, of course, I thought that I would get wounds from that when I build everything. In the evening of the same day, I felt that I started to get hot everywhere and I had hot waves from my toes to my head, this was mostly felt on the surface of my skin and I felt really bad for two days, as if I had a fever. Of course, I didn't have to go to the emergency room again because of this, because a lot of things have already happened to me here....

When I have researched the almost intentional mistakes that happened in our medical care, which caused our problem citizens to die, Päivi Kok's actions did not reduce my doubts at least. These persons are clearly playing with the spirit of their patients, where unfortunately they even sometimes succeed.

Medical retaliatory measures

Has the anger and bitterness caused by the deaths in Hyvinkää triggered a desire for revenge in our medical care, which is then carried out on our problem citizens chosen by the medical care just to make sure that they would not kill their possible future innocent victims, so the medical care has taken this into account and is still very active. However, this is a bit wrong in that I see psychiatry as entirely to blame for the fact that Hyvinkää's death happened in the first place, so the hospital itself can only blame itself for this.

However, Jarno Laapotti died in 2008, so if the background of his case was the intentional action of medical care, it only proves that this action has happened before and it did not start after the Hyvinkää incidents in 2012. However, this case could have brought efficiency to this activity, which we can read about in the newspapers every now and then.

Päivi Kokki's methods give support to Jarno Laapotti's death

My childhood friend who died in 2008 initially had a pulmonary embolism, which he survived, and after that he suffered a cerebral embolism or cerebral hemorrhage....the exact cause of death is not known. Today, Laapotti had also gotten lost in the aggressive advertising services in Ylivieska that

psychiatry provides to their patients, of whom unfortunately too many second-class citizens have died within the scope of these services.

For a long time, I have had a suspicion behind Laapotti's death that someone simply drank or fed him something toxic, which caused his blood to clot.

Accusations like this towards our authorities are classified as mental illness in Finland by Dr. Hannu Lauerman, so saying this out loud can lead to official institutions in Finland, which are as closed off as North Korea, which I myself have been able to find out when Olena contacted the ministers of our country and the people in charge of medical care about my desire to meet people in mental hospitals in our country who the reported cases have aroused my interest in the illegal actions of the authorities and how these patients appear in the medical studies of the professors of the University of Turku, where they are investigating the imaginary mental illness of the patient, which is diagnosed on the basis of behavior using cutting-edge medical technology. In these studies, which are carried out on patients whose autonomy has been taken away so they cannot refuse the studies, the effect of chemical compounds at the cellular level is actually studied and of course what else modern medicine wants to study on these human rats.

Psychiatry whose activities radiate undirected and systematic illegal activity in their actions where patients are deliberately driven to the brink of natural deaths, where getting caught is extremely unlikely with the knowledge of the Finnish police. This theory, which I initially offered for Laapot's death, enjoys an extremely high level of immunity in terms of being caught, because such suspicion in the direction of medical care has been diagnosed as a mental illness, and we unfortunately have a lot of false evidence of that in Finland because the police do not perform their duties.

However, my suspicion about the cause of Laapot's death leans more towards Kok's procedure with me and the death of Dextra's patient, where the patient got a bacterial infection during surgery, which may actually be as intentional as Kok's methods for me, where he deliberately did not use disinfectant even though I pointed this out to him. Even Laapotti could have gotten these blood clots as a result of a deliberate action if, for example, he has given blood tests, in which case the nurse has acted like the Koki taika Dextra nurses.


From Henriikka, I only received belittling behavior and comments like "have you done construction work" when he commented on the overgrowth of leather. I've had to find out myself about diseases like this, which are suitable for hand overgrowth, it's quite common in muscle infections, which could explain this because I've had really sore muscles and I've had to rub them a lot

When I felt numb, Henriikka felt my scalp and asked "do you feel this" and so she held my fingers and repeated the question. Well damn, of course I feel, but when I had a situation of numbness, I wouldn't have felt if someone was holding my finger.

If we look at the level of medicine that Riepponen offered me, he actually offered me a medical service from somewhere at the beginning of the 20th century, which must have included squeezing fingers and making diagnoses based on them, even though we have extremely high-level medical technology in the country that can be used to examine a person, but more obviously these devices have only been spared for studying human rats at the University of Turku.


I got a referral to Hyvinkää, of course, which may have been dictated by necessity, but this was canceled for some miraculous reason, which I don't know now. Here again, it becomes clear that I simply don't want to be examined properly and it shows as fluff and belittling.

In the referral made by Riepponen, you can see how he has recorded that he "argues against" the referral. I have tried to seek help from our medical care for the muscle twitches that started after I left Focusplan and no one in our medical care wants to provide the service that the law says, but the only thing Riepponen is willing to give is his own judgment towards his patient. These kind of records can actually be a sign when sending for further tests that the receiving doctor there knows that the patient is now being sent back home, just like in Karttunen's HUS, even though he had a post-trauma metabolic reaction in his body, where he finally died when the guy was pumped full of antidotes from all over the world.

This kind of recording in the patient records is close to branding, so there is a big question mark, how the doctor who follows the referral will act in these situations when other stigmatizing information has been recorded in the patient records.



Riepponen's actions support my claims about bad treatments in medical care

Because as a private person, I investigate the bad treatment methods directed at our problem citizens, which in the worst cases they die of which the best example is the murder of Jimi Karttusen at HUS, which was made possible by bad treatment and deliberate misinterpretations of the patient's condition..

At least Riepponen's actions with me did not remove my doubts about his second-class medical care services, which has already proven to have caused one person to die. Investigating Karttusen's

murder is of course very challenging because no one is ensuring the impartiality of the police, and of course it follows from this that criminal investigations can, if necessary, be very nominal in the direction of medical care.

Terttu Heikinheimo-Connell certainly handled the referral to the extent permitted by the law, however, even if he wanted to see the patient, and these actions clearly showed a sense of humor, just like in the case of Karttusen, where he eventually died.

Riepposen has a terrible need to block my referral and return me to private doctor Jari Ikonen, who has already blocked my referral once and said that this case of mine does not need to be investigated further. This of course means that my case would just be buried quickly and my nervous symptoms would not be investigated further.

At this point, I again bring up my desire to get a referral made by Riepponen to a specialist, where Riepponen shows his difficulty and how he just wants to send me back to my own doctor, Jari Ikonen, who already blocked my examination once.

If Riepponen were to succeed in this, it would mean the interruption of my treatment by Ikonen, and that is the reason why I hold on to the recording so much that Riepponen would make a referral to me because Ikonen would not do it.

Riepponen invites me to the nurses' reception room, where one of the nurses is also taking care of the emergency phone. Riepponen urges me to go to Klaukkala health center on Monday to the doctor Ikonen to take blood tests, but the nurses make an appointment for me on Tuesday, to which Riepponen says to go to Ikonen on Tuesday. This is extremely misleading activity in my opinion.

I commented to the nurses about the call time that if anything, I would rather go to the location and tell them about this situation because it is so difficult to remember everything on the phone. To this, the nurses say that I should go through an appointment, that they can only give call times.

You can hear from the recording how difficult and unwilling the nurses are with me and how they justify these actions with protocols.

It is obvious how services for "unwanted" citizens have been created in our country's medical care and how they are dealt with in an extremely systematic, orderly manner and above all in cooperation with other nurses, and this is clearly audible from the recording.

This is a clear proof of my claims based on Karttunen's news about how he was murdered in HUS with the help of deliberate bad treatment, which is clearly audible in my recording.

Karttunen, who left the medical care, has been put through a similar process by the nurses that I also had to do in Nurmijärvi's emergency room, where extremely misleading behavior is created for the patient in all the ambiguity, which is the reason why Karttunen also left the medical care.


I tried to kindly say that they could focus on my case now that I'm here, but I only got the answer that they have more urgent things now.

Riepponen stated with a mutu feeling that the nerves, including the functions of the cranial nerves, which functioned quite normally and there was nothing unusual, were functioning exactly as everything I told in the emergency room was canceled. At the end of the recording, Riepponen lets out a really long sigh that sounds more like a brain fart from his own actions, which is all absolutely incredible crap from a doctor if I may say so.

This kind of activity is apt to block all unwanted patients from medical care.



If we look at deaths that have occurred in nursing care, of which the link above is a good example, the Riepponen / Kokki duo is a really good personal example of how a nurse REFUSES not to use a disinfectant even though the patient points out that such actions in nursing care are not injuries or negligence, but completely intentional actions that are carried out until the end although the patient points it out, which unfortunately has led to the death of many problem citizens.


